WHETHER ENGAGING IN THE PROGRAM OR GOING INTO THE COMMUNITY, THE ENRICHMENT CENTER IS COMMITTED TO HELPING INDIVIDUALS WITH DEVELOPMENTAL DISABILITIES ACHIEVE THEIR GOALS AND LIVE THEIR BEST LIVES.

DURING THE 2021-2022 FISCAL YEAR, WE EXPERIENCED MILD GROWTH FROM PREVIOUS YEARS, BUT NOT TO THE SAME LEVEL PRE-COVID-19. NATIONWIDE STAFFING ISSUES AND COVID-19 WERE THE MAIN FACTORS THAT IMPACTED THE PROGRAM. IN 2020 THERE WERE MANY LAYOFFS AND THE NEED TO REHIRE RETURNED LATE IN 2021.
